- An Associate's Degree in Social Science, Behavioral Science or related field OR 2-3 years community-based work experience in community health or social services
- Current Certification as a Community Health Worker (CHW) OR Initiation/completion of CHW educational requirements after one year of employment
- Proficient with Microsoft Word, Excel, and PowerPoint
- Current valid Ohio driver's license & access to a motor vehicle

Preferred Qualifications:

- One of the following:
 - A Bachelor's Degree in Social Science, Behavioral Science or related field
 - An Associate's Degree and 2 years of experience as a Community Health Advocate I

 - 5 years of work experience as a Community Health Advocate I

Responsibilities include but not limited to:

- Serves as a role model, mentor, and advocate for fathers/expectant fathers to promote responsible and involved fatherhood by providing support through life experiences and connects fathers with resources
- Serves and participates on a community task force with community partners to implement a five-point program, *Every Parent Matters*, to reach fathers and ensure fathers keep engaged
- Performs care coordination through outreach and home visits to perform health assessments of clients and educate them on various health topics
- Connects fathers with each other and Links/refers fathers and men to services available within the agency and community
- Participates on various fatherhood and men's health initiatives to address the social, behavioral and health risk factors related to birth outcomes, contributing factors to infant mortality, and men's health.
- Develops health awareness about topics pertaining to men's health, pregnant women, expectant fathers, and their families through public speaking, audio-visual programs, and promotional materials presented to community groups, agencies, schools, and health fairs
- Assists with planning and development of community health-related programs including curriculum, program material, educational pamphlets, and related literature; Partners with community groups, agencies, and schools to network and promote healthy outcomes
- Assists with data collection and assessing program outcomes; Evaluates the effectiveness of educational efforts; Complies with grant requirements, including periodic reporting
- May be required to play an active role in the event of a public health emergency, which may include changes in responsibilities and working hours
